Welcome to our first quarterly higher education newsletter! This newsletter will keep you informed and engaged with the latest updates on ABAI's educational initiatives. As accreditation and recognition serve a crucial role in ensuring quality and standards of our academic programs, this newsletter serves as a resource for sharing announcements, upcoming deadlines, and beneficial resources so programs can stay ahead in maintaining excellence.

Announcement: We are excited to share ABAI's Recognition Committee recently voted to extend waiving of the following eligibility criterion: the program must have at least one graduate. This waiver is extended an additional year, through December 31, 2026, for established VCSs transitioning to the Tiered Model and applying for recognition (Tiers 2a-4b). Please read the Guidance for Transitioning to the Tiered Model to see this update and more information related to your program's transition to ABAI recognition.

Reminder - Increased Fees: Effective July 1, 2025, the following site visitor fees will be implemented for U.S. based programs undergoing initial and reaccreditation:

TIERED MODEL of EDUCATION

The model is based on the ABAI Accreditation Board standards (Tier 1) and includes four tiers, or levels, of recognition, leading toward ABAI accreditation.

The tiers are organized by three factors:



Whether the program is housed in an institution of higher education

Tier 4 is available only to non-US programs that are housed outside of a higher education institution. These are areas where behavior analysis may not be formally recognized or are developing and need supports to grow in the region.



Whether it produces academic degrees

Degree programs are encompassed in tier 2. Non-degree programs (such as post degree certificates) are encompassed in tier 3.



Whether it includes supervised experiential learning

Tier 1 and tiers with an "a" designation require supervised experiential learning. Programs recognized at Tiers 1, 2a, 3a, and 4a provide students with hands on experience applying the principles of behavior.

BREAKING DOWN COMPONENT STANDARD 6-100

6-100: The faculty consists of behavior analysts who document their expertise in the applied, experimental, or conceptual analysis of behavior. The core faculty consists of full-time doctoral-level behavior analysts. Other program faculty, full- or part-time, have master's or doctoral degrees in behavior analysis or a related field.

"Core Program Faculty" devote at least 50% of their professional time to program-related activities—this does not include broader department administration or teaching in programs outside the accredited or recognized program.

"Associated Program Faculty" make a substantial contribution to the program (e.g., faculty within the department that teach program courses).

"Other Contributors" have a role in the program, but to a much more limited extent than core or associated faculty and have minimal contact with students (e.g., adjunct faculty, supervisors, seminar presenters, etc.).

Do all faculty have to be BCBA-Ds?

No. The faculty standards do not specify certifications nor licenses. Not all doctoral-level behavior analysts are BCBA-Ds (though your program's objectives may necessitate relevant training, certification, or licenses).

What is the required faculty to student ratio?

ABAI's standards do not specify a required ratio of faculty to students. The standards request the program to demonstrate (in standard area 6 and its component standards) the faculty are sufficient in number and quality to fulfill the program's mission. It is important for the program to provide an analysis of faculty workload and teaching requirements, supervisory roles, administrative duties, class sizes, and other information beyond a student-to-faculty ratio.
